**1. Call to Order**

A Special Public Meeting of the Port Hawkesbury Town Council was held in the Boardroom, PHCC, Monday, April 8, 2019 and called to order by Mayor B. Chisholm-Beaton at 6:38 p.m.

**2. Approval of the Agenda**

**MOVED by Deputy Mayor M. MacIver and SECONDED by Councilor B. MacQuarrie “that the Town of Port Hawkesbury approves the agenda as distributed”. MOTION CARRIED.**

**3. Resolution – Construction Agreement – 2019-001 – Trunk 4 Reeves Street Road Upgrades – CAO, T. Doyle**

A motion was required by Town Council to approve a resolution from the Province to construct upgrades on Trunk 4 (Reeves Street) from MacSween Street easterly to the intersection of Trunk 4 and Industrial Park Road in Inverness County and to perform work on and adjacent to Municipal owned streets; Reynolds Street, Old Sydney Road and Pitt Street. The agreement allows NS TIR to conduct work on Town properties in relation to the Reeves Street improvements. It was noted that Paragraph 1, Page 1 of the agreement was amended from *Richmond County* to *Inverness County*.

The Town will collaborate with businesses during this process. The project costs would involve purchasing land from Nova Scotia Power to realign the street. CAO, T. Doyle addressed Council’s questions relating to liability and access issues.

**MOVED by Councilor T. Boudreau and SECONDED by Councilor B. MacQuarrie “that the Town of Port Hawkesbury approves a resolution which allows the Province to construct upgrades on Trunk 4 (Reeves Street) from MacSween Street easterly to the intersection of Trunk 4 and Industrial Park Road in Inverness County and to perform work on and adjacent to Municipal owned streets; Reynolds Street, Old Sydney Road and Pitt Street.” MOTION CARRIED.**

**5. Adjournment**


