1. Call to Order

A meeting of the Committee of the Whole was held in the Shannon Studio, PHCC, Monday, May 25, 2015 and called to order by Mayor MacLean at 7:00 p.m.

3. Gallery Presentations

Roles and Responsibilities of Council and Staff

Ms. Emily Pond, Municipal Advisor, NS Municipal Affairs, addressed the requirements of the Municipal Government Act (MGA) relating to a CAO System vs Council as a CAO System within NS municipalities; human resources and the relationship between Council and Staff. She discussed the advantages of a CAO System, CAO responsibilities and Staff requirements, reporting and accountability. Discussion included balancing residents' expectations and perceptions of Council while adhering to the MGA, the costs associated with a CAO system in NS, and the Town Solicitor and CAO reporting relationship. Mayor MacLean noted the importance of good provincial and municipal leadership in NS during these difficult economic times.
