4. Other Business

a) Dog Park

CAO M. Freimanis asked Council for direction regarding the June 2, 2015 Dog Park presentation and discussion on the canvassing of some property owners who have concerns with the preferred park location of the Dog Park Committee and its proximity to the playground. Deputy Mayor J. Janega and Director Marketing, Recreation, Tourism & Culture, P. Davis will contact residents and other individuals as identified at the June 2 Public Meeting and provide a report to Council. Should the Dog Park Committee's preferred location not be acceptable, alternative locations will need to be considered with recommendations to the Dog Park Committee.

b) Grants Pond Gazebo

- CAO Freimanis attended an AMANS Board of Directors meeting September 11 which included discussion on the Land Registry Offices and Property Valuation Service Corporation's interest in integrating the registry with their services.
