A Public Meeting of the Port Hawkesbury Town Council was held in the Shannon Studio, PHCC, Tuesday, October 6, 2015 and called to order by Mayor MacLean at 7:00 p.m.

Freimanis has identified the issue of time and effort involved with repeat offences and the issuance of multiple removal orders to residents who do not comply with an original removal order. 9. Other Business

- a) Approval of Financial Statements 2014-2015
- E. MacEachen stated there was a small surplus this year, that cash reserves increased slightly and that the Town is moving in the right direction. Mayor MacLean commended and credited a team approach and strong management skills by Council and Staff for their work on the 2014-2015 financials.

b) Letter of Support – Belle MacIntyre, Port Hawkesbury Veterans Memorial Park CAO M. Freimanis stated the Town supports the Park but recommended any major additions or renovations should be subject to Council Review. Councilor Dr. T. Boudreau added that the Park façade should work in harmony with the Town.

MOVED by Councilor Dr. T. Boudreau and SECONDED by Councilor B. Chisholm-Beaton "to approve the request by Belle MacIntyre, on behalf of the Port Hawkesbury Veterans Memorial Park, to add a new panel with names of veterans, reinforce flag poles and maintain flower beds". MOTION CARRIED.

c) Date Change - November Public Meeting

Mayor MacLean, members of Council and CAO Freimanis will be attending the UNSM Fall Conference November 3-6 in Halifax. CAO M. Freimanis recommended that the November Public Meeting, which falls on November 3, be changed to November 16, 2015 followed by the Committee of the Whole.

d) Eastern Strait REN (ESREN) – Board Member

Councilor B. Chisholm-Beaton currently sits as a liaison for the ESREN and stated time constraints pose a challenge for committed Port Hawkesbury industry or business persons wanting to sit on the Board. One candidate has been put forward for consideration and she petitioned Council for the recruitment of a second candidate. Additional recruitment could take place pending the decision on these candidates. Discussion included recruitment of candidates with experience in municipal participation and funding formulas based on per capita contributions.
