a) MGA Review – Housekeeping Amendments

b) Planning Advisory Committee (PAC) – Application Information and Meeting Date

An application by Greene's Funeral Services Limited was received to amend the Town of Port Hawkesbury Municipal Planning Strategy and the Land Use By-law by adding existing funeral parlors as a permitted use in the Residential (R-2) zone. A PAC meeting was confirmed for March 30, 2016 at noon to discuss the application.
