#### 1. Call to Order

A Public Meeting of the Port Hawkesbury Town Council was held in Shannon Studio, Port Hawkesbury Civic Centre, Tuesday, April 4, 2017 and was called to order by Mayor Chisholm-Beaton at 7:00 p.m.

## 2. Presentations

2.1 Strait Area Ground Search and Rescue (SAGSR) – Tanya McChesney

In December 2016, the storage building housing equipment was deeded to the SAGSR. Current membership is at 80 members. Costs are increasing and reserves are depleting. Seven municipalities are being asked for operational funding at \$3,000 per municipality. Council will discuss this funding request during budget deliberations.

# 2.2 Pan Cape Breton Food Hub – Jim Mustard and Alicia Lake

There are seven locations responding to the need for local food and producers wanting to provide local food. There are 30 producers of which three are looking to hire new staff. The Food Hub is seeking \$100,000 in funding from the Province to improve services. It is also looking at agricultural land trusts (a land bank). The municipalities are asked to increase their funding based on population. Presently there are 125 consumers with a goal for the upcoming year of 250 consumers. The Food Hub is requesting \$7,500 from other units and \$2,175 from the Town of Port Hawkesbury. Council will discuss this funding request during budget deliberations.

# 2.3 Raising the Villages – Jim Mustard

Mr. Mustard stated the importance of early investment in childhood, the creation of universally welcoming spaces in each community and the developmental milestones that occur in pre-school years. The Raising the Villages Workshop also addressed issues on childhood poverty, mental health, crime, low literacy, addictions, the Universally Accessible Support Services Programs, and strengthening culture and language. The ask from the Town was \$3000. Council will discuss this funding request during budget deliberations.

# 11.1 Destination Reeves Street Project

Discussion included the date of the public consultation process. The Destination Reeves Street Project proposal was submitted to the province. The Town is awaiting their response in order to move forward to the next stage. Should the Town proceed with road dieting; the Destination Reeves Street Project Committee and the NS TIR will meet with business leaders and the public for feedback on the design.

Councilor M. MacIver would like to attend the meetings. CAO T.Doyle will provide a complete update on the concept design to Council. The detail design process will be the next step after approval. Councilor H. MacDougall inquired if the project funding was approved. Finance Director E. MacEachen stated there were two years of funding from the gas tax approved and a possible third year from gas tax funding pending project development.

## 11.2 Minutes – March 3, 2015 – The Devils Brigade

Councilor H. MacDougall asked that the correction of the name of the unit and amendment be made to the March 3, 2015 minutes, Agenda Item #10 – The Devils Brigade:

Recognition of the 1<sup>st</sup> Special Service Force – Councilor Dr. T. Boudreau

Councilor Dr. T. Boudreau stated the 1<sup>st</sup> Special Service Force was honoured with the Congressional Gold Medal, the highest civilian honour the United States Congress can bestow. It was noted that

Donald MacDougall, called first, and Hector MacInnis were part of the 1st Special Service Force, a joint American-Canadian Special Forces military unit that was revered for their service during World War II. In 1968, a movie by the name of The Devil's Brigade was made to honour the 1<sup>st</sup> Special Service Force unit.

## 11.3 Waterfront

Discussion included the formation of a committee of Council to discuss the waterfront and requirements for preparations of the Canada 150 celebrations. An ad hoc committee will be created for the Canada 150 Celebration and the Tall Ships.
