1. A Public Meeting of the Port Hawkesbury Town Council was held in Shannon Studio, PHCC, Tuesday, September 5, 2017 and called to order by Mayor Brenda Chisholm-Beaton at 7:00 p.m.

3. Gallery Presentations

i. Blue Dot Movement

The Blue Dot movement is a nation-wide campaign supporting Canadians' right to a healthy environment. The movement calls upon local communities to 1) pass municipal declarations respecting people's right to live in a healthy environment; 2) inspire provincial and federal decision-makers to pass environmental bills of rights; and, 3) an amendment to the Charter of Rights which would protect Canadians' right to a healthy environment, world-class standards and a voice in the decisions that affect our health and wellbeing. A question period followed. Council was asked to participate and support 'The Right to a Healthy Environment, a Model Municipal Declaration and send a letter to the provincial and federal governments calling for the development of legislation that recognizes that all people have the right to live in a healthy environment.

ii. CBU 5 Year Plan

The presentation by Dale Keefe, Richard MacKinnon, and Gordon MacInnis included CBU's 15 year history of changes, information on provincial funding and tuition, the 2017/2018 Operating Budget, the university's economic impact for Cape Breton and the change to enrollment with an increase to the international and aboriginal student enrollment and a decrease to the domestic student enrollment. A question period followed. Discussion included the university's recognition as a globally competitive institution, changes in programming due to an increase in international student enrollment and moving forward to promote and foster a broader island community appeal for the university.

4. Audit Committee Presentation

Kim Livingston and Ryan Armstrong provided a high level review of the March 31, 2017 Non-consolidated and Consolidated Financial Statements and the Report to the Audit Committee. The audit did not identify any unadjusted non-trivial misstatements from disclosure matters. E. MacEachen and her staff were commended for their work resulting in a clean audit.

i. Approval of 2016-2017 Audited Financial Statements – Julie Marchand, Chair, Audit Committee

The Audit Committee met with the Town's auditors, Grant Thornton on May 11, 2017 to review the audit plan for the March 31, 2017 year and again on August 2, 2017 to review the results of the audit. Based on the results of the meetings, the Audit Committee's recommendation to Council was to 1) approve the March 31, 2017 audited financial statements as presented to the Audit Committee, August 2, 2017; and, 2) enter into an RFP process for solicitation of Audit Services in advance of the next fiscal year.
