4. Gallery Presentations

NS Health Authority, Senior Director, Medical Affairs, Grayson Fulmer

On behalf of the NS Health Authority, Mr. Fulmer provided an update on Physician Recruitment in Nova Scotia. The four organizations involved and who have a defined role in the physician recruitment process are the Government of Nova Scotia, Dalhousie Medical School, the College of Physicians and Surgeons, and the NS Health Authority.

Mr. Fulmer's presentation included an overview on recruitment focus, drivers, and its strategies; statistics on physician vacancies and site visits within the province; and, the current number of Dalhousie medical residents and graduating students. He stated collaboration between our physicians and community partners is key, and that although recruitment gets physicians in the province, focusing on retention is vital. A question and answer period followed on issues of a community toolkit, the physician deficit in Port Hawkesbury, recommended recruiting incentives, and caseload benchmarks for family physicians. Mr. Fulmer stated a physician recruiter will provide Mayor B. Chisholm-Beaton and Councilor T. Boudreau with information on their questions regarding a recruiting model and how best to promote Port Hawkesbury in the physician recruitment process.
