Quality of Life Index

The Nova Scotia Quality of Life Initiative is a multi-year project involving a broad range of organizations from across the province that measures how Nova Scotia compares to other provinces across eight domains of wellbeing. The presentation by April Sampson and Kevin MacEachern included data compiled from a survey measuring success and the quality of life of 1000 Nova Scotians. Surveys will be distributed by mail to one in five households in NS to participate in an online survey. A quality of life report will be generated for 10 regions across the province. 11. Other Business

i. Landrie Lake Water Utility

The Municipality of the County of Richmond and the Town of Port Hawkesbury are joint owners of the Landrie Lake Water Utility. The UARB approved the utility transfer, a new schedule of rates and a schedule of rules and regulations. Deputy Mayor M. MacIver and Councilor H. MacDougall accepted the nomination by Councilor B. MacQuarrie to sit on the newly formed Landrie Lake Water Utility Committee.

MOVED by Councilor B. MacQuarrie and SECONDED by Councilor T. Boudreau "that the Town of Port Hawkesbury approves the appointment of Deputy Mayor M. MacIver and Councilor H. MacDougall to sit on the Landrie Lake Water Utility Committee". MOTION CARRIED.

ii. Inverness County Home Support Society (ICHSS)

Councilor H. MacDougall provided a summary of his concerns relating to the potential closure of the Port Hawkesbury ICHSS sub office. Research for the ICHSS amalgamation agreement is being conducted. Discussion included cost efficiencies that may be gained for the ICHSS in the event of a closure. Councilor H. MacDougall will provide Council with updates accordingly.

iii. Eastern Counties Regional Library (ECRL) Funding

Councilor B. MacQuarrie expressed concerns relating to the Province's 49% increase to the Town's contribution noting that it was conducted unilaterally across the province and without consultation to municipalities. Councilor T. Boudreau stated the increase is a result of changes to the French and equity grants and the lack of funding increases since the ECRL 2010-11 fiscal year. He discussed the potential for a tiered funding approach. Staff will draft a letter for Council's review to be sent to Leo Glavine, Minister, Communities, Culture and Heritage expressing concerns about the funding increase.

MOVED by Councilor B. MacQuarrie and SECONDED by Councilor T. Boudreau "that the Town of Port Hawkesbury send a letter to Leo Glavine, Minister, Communities, Culture and Heritage, expressing concerns about the increase in funding imposed on the Town under a new provincial library funding formula". MOTION CARRIED.

iv. Granville Street Traffic Study

CAO T. Doyle provided a summary of the Granville Street Study Open House held December 5, 2018. An engineering proposal for the traffic study has been received. The cost of the traffic study will be discussed during budget deliberations. Deputy Mayor M. MacIver stated the radar sign that was relocated from Reeves Street to Granville Street was not recording data. Staff will make the necessary changes to ensure the radar sign is working properly.

v. Reeves Street Tender

A conflict of interest was declared by Deputy Mayor M. MacIver who vacated Council Chambers at 7:50 p.m. CAO, T. Doyle stated three bids were received for the Reeves Street: Complete Street Upgrades Tender (#TOPH201901). The lowest bid was received from Dexter Construction (Bid: Year 2019 - \$1,190,099.00; Bid: Year 2020 - \$309,808.00 (subject to funding availability). The first meeting with Dexter Construction is scheduled in three weeks.

vi. Residential Curbside Spring Clean-up
