

TOWN COUNCIL
Minutes of Meeting
January 6, 2009

1. The regular monthly meeting of the Port Hawkesbury Town Council was held in the Shannon Studio, Port Hawkesbury Civic Center, on Tuesday, January 6, 2009, at 7 p.m.
