8. Council Committee Reports

- i. Report from the Committee of the Whole September 17, 2019
 - a. November Public Meeting Date

MOVED by Deputy Mayor M. MacIver and SECONDED by Councilor H. MacDougall "that the Town of Port Hawkesbury approves rescheduling the November Public Meeting date to Monday, November 4, 2019". MOTION CARRIED.

b. By-Laws and Policies Review

Low Income Tax Exemption Policy – Section 2.3 – Principal Residence

After further review, Councilor H. MacDougall indicated his opinion was that *Section 2.3 Principal Residence* clause should remain in the policy. Deputy Mayor M. MacIver and Councilors Boudreau and MacQuarrie were in agreement.

<u>Low Income Tax Exemption Policy Application Form – Removal of Condition #6</u>

CAO T. Doyle stated in accordance with Section 48 (1) of the MGA, a notice of seven days to Council is required before a policy is passed, amended, or repealed. As Condition #6 (*Applicant must not be eligible for any other rebate program*) was discussed at the September 17, 2019 meeting of the Committee of the Whole, the time requirement has been met. Council agreed to remove this condition from the Low Income Tax Exemption Policy Application Form. (The remaining conditions will resume numerical order).

MOVED by Councilor T. Boudreau and SECONDED by Councilor H. MacDougall "that the Town of Port Hawkesbury approves the removal of Condition #6: *Applicant must not be eligible for any other rebate program*, from the Low Income Tax Exemption Policy Application Form". MOTION CARRIED.

Dangerous and Unsightly Premises Policy (discussed at September 17, 2019 Committee of the Whole)

CAO, T. Doyle received clarification from Planning Staff that two neighboring municipalities and members of the EDPC with similar policies contain the following paragraph (4):

In the instance where a complaint of allegations of dangerous or unsightly premises contrary to the Municipal Government Act is submitted by a municipal Councillor, the Councillor shall declare a conflict of interest and remove themselves from all discussion and/or Council decisions relative to the complaint.

The amendment to the Town's policy would only include the addition of Paragraph 4.

MOVED by Deputy M. MacIver and SECONDED by Councilor H. MacDougall "that the Town of Port Hawkesbury approves the addition of Paragraph 4 to the Dangerous and Unsightly Premises Policy". MOTION CARRIED.

MacQuarrie "that the Town of Port Hawkesbury, approves First Reading of the proposed amendment to the Port Hawkesbury Municipal Planning Strategy and Land Use By-law to re-designate the properties located at PIDs 50156322 and 50317395 from the Residential to the Commercial Designation and that Council approve the rezoning of the same properties from R-4/R-5/R-2 to Mixed Use (M-1) zone". iii. By-Laws and Policies Review

Low Income Tax Exemption Policy and Dangerous and Unsightly Premises By-Law As presented in the report from the Committee of the Whole.

Council agreed to defer discussion to the October meeting of the Committee of the Whole on the Destruction of Documents By-Law, the Garbage Collection By-Law and the Subdivision By-Law three by-laws determined by staff to be repealed because of their replacement by policies. Staff will remove by-laws that that have been repealed from the website.

iv. Expense Report – September 2019
