#### 13. Other Business

i. Second Reading – Rezoning of Lands – Municipal Planning Strategy and Land Use By-law Properties PID #50156322 and PID #50317395

MOVED by Councilor T. Boudreau and SECONDED by Councilor M. MacIver "That the Town of Port Hawkesbury approves Second and Final Reading to amend the Municipal Planning Strategy and Land Use By-law to re-designate properties located at PIDs #50156322 and #50317395 from the residential to the commercial designation, and: the Town of Port Hawkesbury approves the same properties from R-4/R-5/R-2 to Mixed Use (M-1) Zone." MOTION CARRIED.

ii. Second Reading – By-law to Amend the Land Use By-law – PID #50273309

MOVED by Councilor M. MacIver and SECONDED by Councilor T. Boudreau That the Town of Port Hawkesbury approves Second and Final Reading to amend the Commercial Restricted (C-4) Zone of the Land Use By-law to include 'recreational cannabis production, extraction and processing' as a permitted use in the C-4 zone". MOTION CARRIED.

iii. Cape Breton Regional Enterprise Network – Council Representation

MOVED by Councilor T. Boudreau and SECONDED by Councilor M. MacIver "That the Town of Port Hawkesbury approves the appointment of Mayor Brenda Chisholm-Beaton to represent the Town on the Cape Breton Regional Enterprise Network Liaison Oversight Committee". MOTION CARRIED.

MOVED by Councilor T. Boudreau and SECONDED by Deputy Mayor B. MacQuarrie "That the Town of Port Hawkesbury approves the appointment of Councilor H. MacDougall as an alternate representative to Mayor Brenda Chisholm-Beaton to represent the Town on the Cape Breton Regional Enterprise Network Liaison Oversight Committee". MOTION CARRIED.

iv. Funding Request – Strait Area Transit – Mayor. B. Chisholm-Beaton
The Town of Port Hawkesbury (in addition to the Municipalities of the Counties of Inverness and Richmond) received a funding request from the Strait Area Transit (SAT) to assist with their continued growth and to improve safety measures for passengers and personnel. Council discussion followed.

MOVED by Deputy Mayor B. MacQuarrie and SECONDED by Councilor T. Boudreau "That the Town of Port Hawkesbury approves a funding request of \$2100 to the Strait Area Transit to assist with their continued growth and to improve safety measures for passengers and personnel". MOTION CARRIED.

v. Racquetball Court Update

Director P. Davis provided an update on the two racquetball courts stating one court is assigned to the Port Hawkesbury Judo Club and the second court has the ability to be converted into a squash court. The renovation costs are not yet determined. The two courts are committed for a 2020 racquetball tournament.

## vi. Physician Recruitment

Mayor B. Chisholm-Beaton provided an update from a meeting she attended with Nova Scotia Health Authority members. A draft Terms of Reference will be circulated to Council. Discussion included interest from the Strait Area Chamber of Commerce to assist with the committee; Council's assistance with identifying committee members; and, promotional materials to assist with recruitment and retention. Councilor T. Boudreau will attend a Doctors Nova Scotia – Recruiting Dalhousie University Medical Learners event in Halifax. Deputy Mayor B. MacQuarrie noted the name of the committee was identified as the *Port Hawkesbury Physician and Health Professional Attraction and Retention Committee*, to reflect the breadth of the committee's vision and a diversity of health professionals .The Deputy Mayor circulated information from NS Communities, Culture and Heritage for potential funding to support community efforts in physician recruitment and retention. Staff will submit an application by the December 1, 2019 deadline.

- viii. Leaf & Yard Waste Site Closure Date CAO, T. Doyle
