MacQuarrie "That the Town of Port Hawkesbury approves the Capital and Operating Budgets as presented April 20, 2021 with a Residential Tax Rate set at \$1.58/\$100 assessment and a Commercial Tax Rate set at \$4.16/\$100 assessment, and a Sewer Service Charge of \$0.22/\$100 assessment for the fiscal year 2021-2022. Property taxes are payable as billed by June 1, 2021 and October 1, 2021 and interest will be charged at a rate of 18% per annum on overdue accounts." MOTION CARRIED.

Deputy Mayor, B. MacQuarrie discussed how he would like to see improvements made in the Port Hawkesbury Business Park. CAO, T.
