## 4. Considerations from Public Hearing

#### i. Elm Court Properties Rezoning

MOVED by Councilor M. MacIver and SECONDED by Councilor J. Aucoin, "That the Town of Port Hawkesbury Re-designate Lots 141 to 149 on Elm Court (PIDs 50156215, 50175264, 50175272, 50175280, 50175322, 50175314, 50175306, 50175298 and 50127281) from the Residential Designation to the Open Space Designation and further that the same properties be concurrently rezoned from the R-2 (Residential Two Unit) Zone to the O-1 (Open Space) Zone." MOTION CARRIED.

## i. C-2 Zoning Amendments

MOVED by Councilor, M. MacIver and SECONDED by Councilor J. Aucoin, "That the Town of Port Hawkesbury amend both the Town Municipal Planning Strategy and Land Use By-law to change a permitted use for the Granville Street/Waterfront Development (C-2) zone from "Places of

entertainment, recreation, and assembly which are conducted within wholly enclosed buildings" to remove the "wholly enclosed building" provision."" MOTION CARRIED.

## 5. Additions to Agenda

## a) Police Advisory

Councilor, H. MacDougall requested that an advertisement go out to the public looking for two Town citizens to join the Police Advisory Committee. Director of Finance, E. MacEachen had stated that the Police Advisory was an item added to the June 15<sup>th</sup> Committee of the Whole agenda.

MOVED by Councilor, H. MacDougall and SECONDED by Councilor, M. MacIver "THAT the Town of Port Hawkesbury approves to advertise for the two open seats for Town residents on the Police Advisory Committee." MOTION CARRIED.

## b) Summer Student Program

Councilor, H. MacDougall had asked the question to staff on what was the status was on the summer students and when they are set to start. CAO, T. Doyle had said that one student had started this week and the other students are staggered to try and fill the gaps over the summer. Manager of Facilities, Parks, and Operations, G.
