Submitted to Council

One Nova Scotia – REAP Project

Our team continues to meet bi-weekly and as needed to progress several must-win battles (two that council may have interest in is regarding Apaq't Place and the establishment of an Offshore Wind Research Centre here in the Strait). We have submitted and successfully secured a joint proposal for \$60K (\$40K will be invested in Apaq't Place at the Port Hawkesbury Waterfront) (\$20K for Rising tIDE fund development which will take the form of a hack-a-thon this Fall or Winter) via Onside (submitted June 10th). I attended an innovation tour at MIT in Boston from June 28-30th which completed the REAP MIT component of our project. The next steps will be to work with NSCCs across the province to continue to work on innovation in the 5 regions (Strait Cape Breton included). I've included our executive summary for Council review, please let me know if you have any other questions.

I travelled to Boston for 3 days as part of an innovation tour hosted by MIT, which generated lots of interest and ideas for the future development of Apaq't Place as an innovation hub at the Port Hawkesbury Waterfront.

At this point our program with MIT is concluded – however – our team plans to continue to move forward the Must Win Battles we have outlined in our executive summary. The team champions and managers will be doing a 1-day workshop with NSCC at the lead near the end of the month (report to follow), to see how they can support further REAP team progress.

Allan J MacEachen Regional Airport

There wasn't a quorum for the meeting on September 12th – and a new date is in the works for later in month. I do what to update on a meeting that resulted from the letter to Minster Susan Corkum-Greek Meeting from our Council re: airport and needed partnership from the Province to invest in its future. (Note: the Allan J MacEachern Regional Airport Committee also sent a letter to the Minister, therefore the original meeting was with the Minister and the two Town representatives on the committee (Myself and Deputy Mayor Aucoin), and the Minister was happy to also accommodate the vice-chair of the airport committee as well (Deputy Warden Melanie Samson). It was a zoom meeting scheduled on September 13. It was a positive meeting. I outlined a bit of the history of the airport and reviewed the strategic session

outcomes and opportunities. Erin (as acting CAO) outlined some of our capital challenges (runway and lighting). The Minister acknowledged that the airport was an important transportation asset to the region and that she, her Deputy Minister, and her team would explore any programs or assistance that may be possible to assist with ongoing development and growth of the airport. On September 15th, I followed up via email to send the Minister a copy of the Allan J Airport Strategy report, meeting notes, and that we'd follow up at a later date when we had a report of what work was needed to the runway.

However not a lot of progress was made and the membership voted to table the remaining decisions at a later date. We hope to have another thorough presentation of the structural changes at the Fall Conference and depending on the wishes of the membership, move to set another Members meeting to complete the process.

Offshore wind Task Force

Deputy Premier Allan MacMaster gave an amazing keynote and the emerging hydrogen and offshore wind industries were some of the key themes discussed.

Marine Renewables Conference: I attended a Marine Renewables Conference on August 11, which provided a lot of great information on offshore wind potential as well as other green renewables for the Province of Nova Scotia and Atlantic Canada.

Coady Institute International Women's Workshop: I helped to coordinate and host a workshop held at Friends United on August 19 for 28 International women attending the summer program to share the work of FOCUS which included the leadership school for women and women's leadership mentorship programs, as well as work done with First Nation Grandmother Elders.
