One Nova Scotia – REAP Project

Destination Cape Breton Association

We continue to work on a survey to distribute to municipal and First Nation elected officials as well as other T&R stakeholders to find out what interest there may be for participation (tentative survey for early new year and first T&R event planned for late spring 2023).

Offshore wind Task Force

The task force meeting was held November 8th virtually – and we continue to learn more about offshore wind, and connect with key stakeholders. We had the opportunity to present to Potlotek First Nation Council on October 25th and were pleased to have a member of Potlotek Council assigned to the task force. Future stakeholder meetings/presentations yet to be determined are with Victoria County Council and Paqtnkek. Both Warden Momborquette and I – as co-chairs – both attended the NetZero announcement via MP Mike Kelloway who announced 1.8 million investment to build capacity primarily in partnership with UNIR and with First Nation Communities as well as other community stakeholders. Councillor Aucoin also joined the announcement. With the committee reassignments, I also notified our executive that Councillor Blaine MacQuarrie would also be serving on the OSW task force as a council representative – so he can be added to the future meeting emailing list.

Other work:

Investors Summit (CBP): I attended the Investors summit which is a two-day summit held in Ingonish and hosted/organized by the Cape Breton Partnership. The dates were from November 19th/20th and it was well-attended and we heard lots of wonderful updates regarding investments from all across Cape Breton Unama'kik.

Offshore Wind Announcement: I was invited by MP Kelloway and NetZero to attend the offshore wind funding announcement held at the Port Hawkesbury Civic Centre (Port Hawkesbury) on November 10th that will see \$1.8 Million invested into capacity building in the region for offshore wind.

Meeting re: PVSC: I was invited by Jimmy McAlpine to attend a meeting to discuss our municipalities questions and concerns with PVSC – and the meeting was attended by CAO Terry Doyle and CFO Erin MacEachen. Held in the boardroom on .

Mike Kelloway: (Virtual Meeeting) Mike Kelloway agreed to meet with Mayor, CAO and Councillor MacQuarrie to discuss Dr. Atul on October 27th – Mike Kelloway's team were to follow up with Dr. Atul and his wife on their files re: immigrating to Canada, specifically to Port Hawkesbury Nova Scotia.

Mike Kelloway: We have a virtual meeting planned/set with Mike Kelloway to discuss Federal budget / priorities and to discuss Port Hawkesbury priorities on November 22nd. I encourage all of Council to attend (you've all received a calendar invite.

Media Coverage – Hurricane Fiona: I did several television and radio interviews regarding pre- during- and post-Hurricane Fiona and the EMO preparations and response by the Town of Port Hawkesbury.

NSFM Fall Convention: I attended the 4 day conventions – the first day was for registration and for caucus meetings and a meet and greet, and the remaining days were filled with keynote speakers, training sessions, networking opportunities, and political forum that included an address from Premier Houston, as well as the other party leaders/representatives (Liberal, NDP and Green). We were also fortunate to have a presentation on the final day by MP and Minister Sean Fraser who spoke to the importance of the federal work currently underway – especially with the Immigration file. Special thank you to Councillor Aucoin to organized a great prize giveaway that included a flight tour of Cape Breton from Celtic Air services overnight stay at the Maritime Inn and dinner at Millers and Breakfast at the Fleur de Lis. As the outgoing vice-President of NSFM – I was one of the key organizers for this conference and chaired many session and am pleased to report that we had amazing feedback from the membership about how wonderful it was to be together after a long hiatus due to Covid 19.

Committee Selection Meeting (Nov 7): A meeting was held to solidify committee (local and regional) selections – all committee assignments and/or reassignments were moved forward to the Public Meeting held the following night (Nov 8th).

Marine Renewables Canada Conference: I have been asked along with co-chair Amanda Mombourquette to chair a session at the upcoming Marine Renewables Canada Conference this November 22, 23 and 25. I attended a virtual meeting with Elisa Oberman and the panel presenters and co-chair Warden Amanda Momborquette to prepare for the conference as

panel hosts. We are looking forward to this opportunity to host a panel and to have the opportunity to discuss the OSW Task force and showcase the Strait of Canso.

Remembrance Day Ceremony (Tamarac Education Centre): I was invited to address the grade primary to grade 8 students at TEC on November 7th. In my address I spoke about the special decision made together by the Town of Port Hawkesbury and the Legion after World War 1 to rename many of the Town's streets (then named after colours) after the war heroes who lost their lives in World War 1.

Ribbon Cutting (Mark Farrow): I was invited by Mark and the Chamber of commerce to participate in the official business opening and ribbon cutting for Mark's new laundry and signage business – held at noontime on November 7th at the business location. Mark noted he was grateful for all the support Council demonstrated in assisting with the advertising sign and support in general as a business owner. Councillor and incoming Deputy Mayor was in attendance as well.

Honorable Bill Blair re: Disaster Financial Assistance and EMO (virtual): I was invited to attend a virtual meeting that addressed the outcomes and needs post-hurricane Fiona and ways we can be better prepared from an EMO perspective in the future. Many participants representing the Province were in attendance (Minister Lohr and others from municipal affairs and housing) as well as several municipal mayors and wardens (November 8th). I asked Minister Blair about potential response federally – as well as Minister Lohr Provincially) what would happen in the instance that the Canso Causeway – as a critical transportation connector – was damaged significantly due to a weather event – and that a firm EMO multistakeholder plan is needed so we are prepared – as well as a financial plan to repair or replace this important transportation asset that connect Cape Breton to mainland Nova Scotia. Minister Blair noted that it was very much on their radar prior to Fiona striking Atlantic Canada and that the Federal government would be prepared to assist if and when that kind of a disaster ever befell the Strait of Canso Causeway. Minister Lohr noted that there is an EMO plan for the causeway and both agreed to the importance of ensuring all of the surrounding local governments are aware of the plan to be prepared for future weather events.

Remembrance Day Ceremony (Veterans War Memorial Park): I was invited to address the veterans, legion members, fire fighters, rcmp, cadets and community members at this year's Remembrance day ceremony on November 11th. I also attended the community luncheon hosted by the Legion after the ceremony. Many remarked how wonderful it was to see so many in attendance. I was truly heartwarming to see so much support from the town and the region, and I know the legion truly appreciated it.

Friends United Truth and Reconciliation Talks: I was invited by Rolf Bowman to participate with Government FOCUS co-chair Karen Bernard to discuss the gender equity work we've done together with host Nancy Regan on November 14th at the Friends United location in Richmond County.

CoLab Housing Assessment Meeting (Virtual): I organized (on behalf of Council) to meet with CoLab consultants to discuss Port Hawkesbury housing needs. CoLab consultants are aiming to meet with every municipality so the Province of Nova Scotia can gain an accurate picture of how housing affects all municipalities from coast to coast to coast. The session was held November 14th attended by Deputy Mayor MacDougall and Councillors Aucoin and MacQuarrie.
