1. Call to Order

A Public Meeting of the Port Hawkesbury Town Council was held in the Shannon Studio and virtually on Tuesday, March 7, 2023, and called to order at 7:00 p.m. by Deputy Mayor, Hughie MacDougall.

Deputy Mayor, H. MacDougall welcomed the Town of Port Hawkesbury's Municipal Advisor, Ross MacDonald to the meeting for the evening.

4. Gallery Presentations

Red Tribe Boxing – Barry Bernard

B. Bernard thanked the Town of Port Hawkesbury for the support at the Boxing event held at the Port Hawkesbury Civic Centre last Spring. He talked about how successful the event was and stated that it was the first boxing event that has been hosted outside the First Nations Community. He talked about the event that is scheduled for this coming May and how he would like to add to the event by adding a Craft/ Cultural market and he is inviting other clubs such as six nations to the event as well as other local Boxing Clubs. Red Tribe Boxing is looking for support for the upcoming Boxing Card on May 20th. Deputy Mayor, H. MacDougall stated that this item will be brought forward for discussion at Committee of the Whole.

RCMP- Staff Sargent, David Morin

Staff Sargent D. Morin provided Council with an update from the RCMP Port Hawkesbury Detachment. He reviewed the District Organization Chart, a breakdown of the Inverness District for human resources and additional services. He reviewed the top 25 offence types across the district for 2021 & 2022, he discussed how RCMP have assisted with medical calls and assisting EHS with transports when no ambulance is available. He talked about staffing levels within the detachment and how the detachment was down three staff members over the past year, and there is a Detachment Services position becoming available within the next few weeks.

D. Morin also discussed the Experienced Officer program, that is focused on recruiting officers from outside policing agencies from around the country. He talked about the current training programs that are available to members. He reviewed the Policing Priorities for 2022: Traffic Safety, Substance Abuse, and Community Involvement. He reviewed the traffic instances results for Reeves Street for 2021/2022, and he reviewed the Traffic Services files in Port Hawkesbury. He reviewed the Drug Enforcement events and the Community Involvement. Council thanked Staff Sargent, Morin for his presentation and expressed appreciation for the greater visibility of the members around town.
