## 1. Call to Order

A Public Meeting of the Port Hawkesbury Town Council was held in the Shannon Studio and virtually on Tuesday, April 4, 2023, and called to order at 7:00 p.m. by Mayor, B. Chisholm-Beaton.

## 2. Additions to Agenda

Mayor, B. Chisholm-Beaton mentioned that the Flag Raising Plan will be discussed under business arising from the minutes and the three letters will be discussed under correspondence.

## 3. Approval of Agenda

# 4. Gallery Presentations

Destination Cape Breton - Chief Executive Terry Smith

T. Smith provided Council with a presentation on Destination Cape Breton's 2023/2024 Strategy. He talked about the Marketing Levy. Destination Cape Breton's Lawyer has drafted a bylaw and CAO, T. Doyle had provided an update at a recent Council meeting. Visit Cape Breton.com sessions seen an increase of 32% over the previous year. He reviewed the past 5-year traffic from the three main markets, Maritimes, Ontario, and Quebec. He also provided an overview of registered room nights sold over the last five years and for short-term rental units (Airbnb & VBRO). He reviewed the tourism forecast and goals for 2023/2024, and talked about enhancing the brand of the island, and research that is focused on in the strategy. A few other items discussed were, research highlights, product innovation highlights, and the marketing plan.

Mayor, B. Chisholm-Beaton asked if there was future consideration to returning after visiting for the marketing plan. T. Smith said that is something that could be looked at and will bring back to his team. The plan is to focus on digital channels and enhance branding. T. Smith mentioned the 2030 vision document. Councillor, B. MacQuarrie mentioned a visitor satisfaction survey sees that it is one of the goals of the strategy. He asked if the results are available to view. CEO. T. Smith said that the assessments have not been conducted due to the lack of resources and staffing. Mayor, B. Chisholm-Beaton mentioned marine supports and that the Town of Port Hawkebsury has two advisory committees that are active in Town, The Port Hawkesbury Development Committee and the Waterfront Advisory Committee. She mentioned the possibility of developing a strategy from a tourism perspective and to have Destination Cape Breton, Cape Breton Partnership, and Develop Nova Scotia, and the Strait of Canso Yacht Club meet to discuss.

#### . Report from Committee of the Whole

#### Canadian History Banner

CAO, T. Doyle mentioned that the Town received a letter from Minister Lohr with the Department of Municipal Affair informing that the Town of Port Hawkesbury has been approved for \$391, from The Sustainable Growth Fund. The funds can be stacked or leveraged for future developments for items such as solid waste management infrastructure, accessibility retrofits for municipal buildings, services-based projects, planning and designing pieces. CAO, T. Doyle will be discussing how to best use this program through the budgetary process.

### 13. Other Business

i. Council Expenses, CAO, T. Doyle

CAO, T. Doyle, gave an update on Council Expenses for the months of March. He reminded the gallery that Council expenses are posted on the Town of Port Hawkesbury website.

ii. Bylaw Officer Priorities – Mayor, B. Chisholm-Beaton

Mayor, Chisholm-Beaton asked what the priorities are around the Town of Port Hawkesbury. Councillor, J. Aucoin will take that forward to the committee on Council's behalf.

Councillor, M. MacIver mentioned that policing the town's bylaws such as parking. Staff could check Bylaw job descriptions for other municipalities that have officers currently.

Mayor, B. Chisholm-Beaton mentioned that maybe an opportunity to streamline some of the bylaws across municipalities. Deputy Mayor, H. MacDougall mentioned that each municipality has their own bylaws. CAO, T. Doyle stated that the Town had repealed a number of bylaws a few years ago. He notified Council that summary offence tickets are being printed and that the RCMP are working with staff. A Constable within the detachment that met with T. Doyle and has moved this initiative forward and he will send a letter of thanks to the staff that have moved this item forward.

Mayor, B. Chisholm-Beaton stated that Council will add for the short term to the Committee of the Whole Agenda.

#### iii. Offshore Wind Opportunities – Mayor, B. Chisholm-Beaton

CAO, T. Doyle reviewed the opportunity for the Mayor and the Town of Port Hawkesbury's shared Economic Development Officer to attend a conference in Copenhagen the end of April. The Province has

confirmed that attendance at the conference would be waived. The Mayor is looking for approval to travel to Copenhagen to attend the Wind Europe Conference. CAO, T. Doyle asked Council to strongly consider the benefits of this conference. The Mayor of the Town to discuss the development of Nova Scotia is an excellent opportunity. He stated that he strongly supports the Mayor and the Economic Development Officer, Martin Thompson to attend. Mayor, Chisholm-Beaton asked if the two elected members that sit on Port Hawkesbury Development Committee could potentially help elevate the Town around Offshore Wind or supply chain developers. Mayor B. Chisholm-Beaton will look for the most economical travel plans as possible.

MOVED by Councillor, B. MacQuarrie and SECONDED Deputy Mayor, H. MacDougall "THAT the Town of Port Hawkesbury support the Mayor to attend the Wind Europe for a cost of \$3,500 and \$750 for the Economic Development Officer, Martin Thompson.

Deputy Mayor, H. MacDougall asked which department sent the invitation. Mayor, B. Chisholm-Beaton confirmed that the invitation came from The Department of Natural Resources and Renewables.

#### Amendment to the Motion

MOVED by Councillor, B. MacQuarrie and SECONDED Councillor, M. MacIver "THAT the Town of Port Hawkesbury support the Mayor, attend the Wind EUROPE for an estimated cost of \$3,500 up to \$5,000". MOTION CARRIED.

Deputy Mayor, H. MacDougall mentioned that travel expenses will still be covered by daily allowances etc.
