#### 1. Call to Order

## 3. Additions to / Approval of Agenda

Donation – Strait Area Under 18 Volleyball Team

MOVED by Deputy Mayor K. Anderson, and SECONDED by Councilor J. King "that Town Council approves the agenda as amended". MOTION CARRIED.

a) Regular Town Council - April 3, 2012

On the question, Councilor M. MacIver inquired on the status to reimburse Jean Ryan for property damage as a result of a second water break on MacDonald Street. CAO, M. Freimanis has discussed this issue with Solicitor L. Evans. This will be itemized for discussion at the next Committee of the Whole meeting.

### 6. Farmers Market Presentation

It was agreed by Town Council to hear the Farmers Market presentation at this time. Mayor MacLean welcomed Amanda Mombourquette to the meeting.

A. Mombourquette and P. Davis provided an update on the interest in a Port Hawkesbury Farmers Market. There have been meetings with the TABLES group (Take Action Buy Local Eat Seasonally) and interest from

20 vendors to have a Farmers Market at the PHCC. Additional meetings have included the Dept. of Agriculture and ECBC. Discussion with Town Council included produce availability; vendor access to the PHCC kitchen and canteen facilities; fees and adherence to the PHCC contract policies; and security and insurance issues. Town Council are in support of a Farmers Market and recommended that A. Mombourquette proceed with planning and provide CAO, M. Freimanis with solid information to be heard at the next Committee of the Whole Meeting or Special Town Council Meeting.
