CAO, T. Doyle gave a quick overview of the Departmental Reports including:

MacDougall asked if barriers would be placed along the newly paved active transportation trail to separate the trail from Water Street. Manager of Engineering and Public

Works, J. MacMillan confirmed that the project is not yet complete and there would be planters and benches placed along the trail as well as new lighting is installed.

CAO, T. Doyle had reviewed the December events, and notified Council that The Town was unsuccessful in securing a company to conduct fireworks for the New Year's Eve celebrations. The Port Hawkesbury Volunteer Fire Department has agreed to be onsite and would look after the fireworks for the New Years Eve event. He noted that there is only one pyrotechnic company in Atlantic Canada and staff reached out in the early summer, but they were already booked.

CAO T. Doyle brought forward correspondence that was circulated in the agenda package from the office of the Nova Scotia Utility and Review Board regarding the Municipal Boundary Review. The Town's Municipal Boundary Review application was received, and a hearing date will be set in the coming weeks.

i. Council Expenses, CAO, T. Doyle

  CAO, T. Doyle and Mayor, B. Chisholm-Beaton Festival of the Strait is not a town committee it is a registered society. Deputy Mayor, H. MacDougall asked if the Town could help support the festival with seeking volunteers and advertising.

Consensus of Council was to move item forward to the January 17th Joint meeting of Council.

- iv. Surplus Equipment Councillor, J. Aucoin Councillor, J. Aucoin had thanked CAO, T. Doyle for putting the surplus out for tender. Councillor, M. MacIver asked if the horse barn has taken ownership of the old tractor. Manager of Facilities and Operations, G. Snook had stated that the tractor is still in Town's possession, until they find an operator.

vi. Housing Open House Sessions – CAO, T. Doyle

CAO, T. Doyle gave a summary of the Housing Open House Sessions that took place on December 14<sup>th</sup> at the Port Hawkesbury Civic Centre. The sessions had good representation from council and had smaller crowds in attendance. The sessions were facilitated by New Dawn Enterprises along with The Strait Area Chamber. New Dawn will host a session for Council in the new year to look at challenges and ways to advocate for the town around housing.

vii. Federal Active Transportation Fund – CAO, T. Doyle

MOVED by Councillor, J. Aucoin and SECONDED by Deputy Mayor, H. MacDougall "That the Town of Port Hawkesbury authorizes their Chief Administrative Officer to execute the Canada Active Transportation Fund Agreement on behalf of the Town of Port Hawkesbury." MOTION CARRIED.

MOVED by Councillor, M. MacIver and SECONDED by Councillor, J. Aucoin "That the Town of Port Hawkesbury allows a reallocation within the previously approved capital plan of \$197,800 of funding to come from the operating reserve instead of the gas tax fund for paving and sidewalks." MOTION CARRIED.

viii. Strait Richmond Minor Hockey Tournament Funding request – CAO, T. Doyle

CAO, T. Doyle reviewed the request that was submitted by the Strait Richmond Minor Hockey Association regarding the Strait Richmond Minor Hockey Tournament, that will occur over several weekends over the next few months. The committee provided a breakdown of financials as per the CAO's request.

MOVED by Councillor, B. MacQuarrie and SECONDED by Councillor, M. MacIver "That the Town of Port Hawkesbury will contribute \$2000 to the Strait Richmond Minor Hockey Association for the 2022- 2023 Strait Richmond Minor Hockey Tournament." MOTION CARRIED.
