Aucoin "That after public consultation and due consideration that the Council of the Town of Port Hawkesbury makes application to the Nova Scotia Utility and Review Board to confirm the number of councillors at 4. That the application shall be prepared pursuant to section 368 or 369 of the Municipal Government Act for use by Towns which do not have polling districts." MOTION CARRIED.

vi. Committees of Council - Mayor, B. Chisholm-Beaton

Councillor, B. MacQuarrie brought up concerns about the size of the newly formed Port Hawkesbury Development Committee that is an amalgamation of the Housing Advisory and Economic Development Committees and asked Council to consider adding another elected member to the membership.

MOVED by Councillor, B. MacQuarrie and SECONDED by Deputy Mayor, H. MacDougall "That the Town of Port Hawkesbury increase the number of elected members from one to two with an alternate on the Port Hawkesbury Development Committee. MOTION CARRIED.

MOVED by Deputy Mayor, H. MacDougall and SECONDED by Councillor, J. Aucoin "That the Town of Port Hawkesbury appoints Councillor, M. MacIver as an alternate on the Port Hawkesbury Development Committee." MOTION CARRIED.

MOVED by Deputy Mayor, H. MacDougall and SECONDED by Councillor, J. Aucoin "That the Town of Port Hawkesbury approve the Local and Regional committee appointments as amended." MOTION CARRIED.

Councillor, M. MacIver asked that all Advisory Committee meetings be held starting in January. Mayor, B. Chisholm-Beaton suggested that request was appropriate to add to the committee recommendations.

MOVED by Councillor, M. MacIver and SECONDED by Councillor, J. Aucoin will being to schedule Committees of Council once the new committees have been formed in January 2023." MOTION CARRIED.

MOVED by Councillor, B. MacQuarrie and SECONDED by Councillor, J. Aucoin "THAT The Town of Port Hawkesbury will adopt the Committee Report Recommendations as amended by Mayor, B. Chisholm-Beaton, Councillor, M. MacIver, and Deputy Mayor, H. MacDougall." MOTION CARRIED.
