- v. Town of Port Hawkesbury Housing Needs Assessment Report CAO, T. Doyle
  - CAO, T. Doyle mentioned that a significant document that has been distributed to Council that was created by the Province of Nova Scotia. This document has been brought forward to the Port Hawkesbury Advisory Development Committee and will be used in the future. His intent is to bring forward to another meeting to discuss this document in more detail.
- vi. Memorandum of Understanding Destination Cape Breton CAO, T. Doyle CAO, T. Doyle reviewed the Memorandum of Understanding between Destination Cape Breton and the Participating Municipalities: Cape Breton Regional Municipality, Municipalities of the County of Inverness, Municipality of Victoria County, Municipality of the County of Richmond, and the Town of Port Hawkesbury. He reviewed the highlighted changes throughout the MOU. He listed the changes throughout the document that are reflected in the Levy.

MOVED by Councillor, J. Aucoin and SECONDED by Deputy Mayor, M. MacIver "That the Town of Port Hawkesbury "That the Town of Port Hawkesbury enter a Memorandum of Understanding with Destination Cape Breton and the Participating Municipalities." MOVED CARRIED.

vii. Town of Port Hawkesbury Travel Policy - CAO, T. Doyle

MOVED by Councillor, J. Aucoin and SECONDED by Councillor, H. MacDougall "That the Town of Port Hawkesbury adopt the Travel Policy as presented at the September 19 Bylaw and Policy Meeting effective October 3, 2023." MOTION CARRIED.

- viii. 2024 Municipal Election CAO, T. Doyle
  - CAO, T. Doyle bringing this item forward in advance of the next election. The Town's Electronic Voting Bylaw was only valid for one year. His intention is to bring forward some options at the next meeting.
- ix. Water Testing Results Councillor, H. MacDougall
  - CAO, T. Doyle mentioned that there have been two tests conducted in the past year. There was a test done in the fall and the summer. He stated that there needs to be a baseline of testing developed to ensure that the water is safe for recreation purposes. The plan is to put a process in place by next spring.
- x. Development Zone Bylaw Director, E. MacEachen
  - Director E. MacEachen mentioned that there is a preliminary draft of this bylaw in the package. This draft was brought forward to the Planning Advisory Committee on November 16<sup>th</sup>. The zone that is focused on is the R-5 which is Reeves Street. Municipalities have been given the ability to phase in assessment through Section 71 of the MGA. The purpose of this Bylaw is to support Economic growth within the Town and to support commercial development. She explained that she would like to have some feedback from Council prior to having first reading. She asked for Councils' opinions on the threshold and parameters of the bylaw. This would have to be

administrated manually. She reviewed a few other parameters that could be options she could take back in the in the first final draft. This preliminary by-law allows for maximum of 50% of taxes rebate for up to 10 years.

Councillor, J. Aucoin mentioned that one PAC member felt very strongly about adding the Industrial Park and Granville Street to the Development Zones.

Councillor, J. Aucoin asked Council to send a follow-up letter to Minister Lohr and our MLA and Alan MacMaster on Mixed Use Phase in tool. Asking the Province to change the legislation to allow residential building to be included in the program. Conditions of the bylaw would be met and include residential in that zone and the change would be made to legislation from the Province.

Deputy Mayor, M. MacIver asked if there are any over six units outside the development zone asking if it would pose a problem.

CAO, T. Doyle mentioned that the Development Zone is meant to be one area of your Municipality to spur on new growth withing the designated zone. The intention is not for the whole town to be a development zone. Councillor, H. MacDougall would like to review the item more before he makes a motion on this item.

MOVED by Councillor, J. Aucoin and SECONDED by Deputy Mayor, M. MacIver "Follow up email from Brenda to Minister Lohr and MLA MacMaster to follow up on the letter that was sent." MOTION CARRIED.

Staff would like to meet **Monday**, **November 27**<sup>th</sup> **at 3pm for a Special Public Meeting** to review and consider project options prior to applying for this program. CAO, T. Doyle will need a resolution of Council for the application.
