Jake Brakes – Councillor, P. Hart

CAO, T. Doyle noted that the jake brakes are not a bylaw issue. Reeves Street is a provincial highway and applicable rules around "Jake Brakes" under the Motor Vehicle Act. He indicated that enforcement is up to RCMP and they are actively enforcing the law. In the past they have put on campaigns before and have asked for signage which is up to the Department of Public Works to provide the signage. Mayor, B. Chisholm-Beaton, noted that it has been a long-standing issue for residents on Trunk 4 and Reeves Street, she has connected residents to the RCMP directly. RCMP can fine the truckers that are using the jake brakes. CAO, T. Doyle noted that D. Morin was by the office late last week to give an update on the issue. Councillor, P. Hart, noted that she is the voice of the community members that live there. Councillor, T. Barrett noted that it has been a high priority topic at the Police Advisory meetings.
